2.2	The Organization	Add the following language to the last line in the 3 <sup>rd</sup> paragraph following the words exterior cameras: "and interior cameras". The sentence shall ready as followed: In presenting this RFP to install network wiring needed for the new border to border wireless nework infrastructure and exteriror cameras, and interior cameras for physical security, we have included the results of the site survey.
4.1	Functional Requirements	<ul> <li>Add the following header and bullet points to the end Functional Requirements: "Interior wiring for Interior cameras</li> <li>All runs should be clearly marked at terminus with labeling on both ends for individual cable with preapproval of labeling by Butler Community College.</li> <li>All cabling must be Belden data twist Cat6 Plenium rated(2413) in Yellow</li> <li>Terminations in the IDF/MDF must be field loadable patch panels - Panduit CPP24WBLY</li> <li>All Network Jacks shall be Panduit CJ688TGYL T568B terminated on both ends of the cable</li> <li>Terminations on the device end shall be loaded in a Panduit CBX1WH-A</li> <li>Terminations on device end shall have a 10ft cable plugged into the network jack and left coiled in the ceiling – Panduit UTPS10YLY</li> <li>All work performed by installation personnel must be in accordance with industry accepted practices, such as those set forth by the EIA/TIA and BISCI. The installation must meet all applicable Federal and State laws, all fire and building codes, and all local jurisdiction requirements.</li> <li>All penetrations of fire-rated walls will also require sufficeient sealing in order to meet existing fire regulations</li> <li>Cables should be neatly dressed and supported in the racks.</li> </ul>

<ul> <li>Each data outlet and cable shall be tested and certified for permanent link compliance with TIA Category-6.</li> <li>All tested cables shall pass all performed tests. End-to-end attenuation loss and NEXT shall meet or exceed Catergory-6, TIA 586-C requirements</li> <li>The contractor will provide all documents easily understood for Inside Wiring cable records showing station ID's, cable routes and proof of certification. Documentation is to be submitted for approval prior to commencement of work.</li> </ul>
